## EVENT FORMAT

**EVENT SCHEDULE:** Coaches meeting will be at 3:30 PM and **play will begin at 4:00 PM on Friday.** Saturday play will start at **8:00 AM.** All pool play matches will be 2 sets to 25, cap 27, with a 3<sup>rd</sup> set to 15, cap 17, if needed. Seeded bracket play will follow pool play; there will be no cap for bracket matches. The winning team of the Championship Bracket will receive the 2021 Champions Challenge t-shirts as well as free entry for the AAU National Championships, the West Coast Championships, or the Volleyball Festival. Absolutely NO age waivers are allowed for AAU Grand Prix events.

There will be no limit on adult spectators. Children under 12 will not be admitted. There will be a gate fee of \$5/person each day. Non-coach rostered adults will be counted as a spectator. Please check-in in order to enter the facility. Make sure to maintain 6' of social distancing from others that are from a different household. Additionally, spectators are required to wear a mask under the current state mandate.

On Friday, there will be NO team entrance prior to 3:00 PM. At Ridgeline & Green Canyon High School, bleachers will be available, but no folding chairs on the wood floors. Folding chairs will be allowed on the track ONLY. At Mtn Peak Volleyball, bleacher seating is available on the upper mezzanine. Please bring your own chair if you would like to sit downstairs or have more comfortable seating.

Concessions like snacks and drinks will be available. **NO OUTSIDE DRINKS** except ones that have a screw-on lid. Please clean up after yourselves.

**ALL-STAR TEAMS:** Coaches will vote for standout athletes for each team they play against. Results will be posted on the Champions Challenge website after the event has concluded and votes have been tallied. These athletes will receive a printed certificate.
